#### Directions to Event Site: Northmoreland Park RVS, FOR SAFETY, PLEASE NOTE SPECIAL DIRECTIONS IN BOLD PRINT

(From the North: Rt. 356 South approximately 6 miles from Freeport, PA to Park entrance on right. **RVS DO NOT USE THIS ENTRANCE.**

**(RVs from North: Rt. 356 approximately 8 miles from Freeport, PA. Watch for RV Entrance "B" sign at Westmoreland Water Authority, turn right and follow signs to the Park.**

(All Vehicles from South: I-79 North to I-70 East to New Stanton, PA. Take Rt. 66 North (toll road) to Delmont, PA. (For those using Rt. 22 & 30, turn North onto Rt. 66. Go approximately 10 miles from the S&T Bank sign in Delmont. Turn LEFT onto "Pine Run Church Road". There is a sign "Pine Run Pools and Spas" at the intersection. Also a "STATE POLICE" sign. Go about one mile and turn RIGHT onto "Pine Run Road."

(Travel about two miles to a "STOP" sign. Turn LEFT onto Markle Road. Follow Markle Road about one mile. There will be a lake on the left.

(Turn RIGHT at Main Entrance to the park and go straight to area designated "Pavilions 1-10 and Main Stage. Follow sign for CSCWP Specialty."

\* NO practicing in the rings at any time.  
\* DOGS MAY arrive any time prior to scheduled time of judging. Dogs not required for further judging will be excused.  
\* JUDGES WILL NOT wait for any dog holding up a class.  
Owners or agents alone are responsible for the presence of their dogs in the ring when their classes are called to be judged. The owner or handler of each dog is solely responsible for having it ready at ringside when its class is to be judged. The show-giving Club and Superintendent have no obligation or responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required. Being an unbenched show, you need to be at show only in time for your judging and may leave any time after judging.  
\*ENTRY FEES will not be refunded in the event that a dog is absent, disqualified, excused by a veterinarian or Judge, or barred from competition by the action of the event's Show Committee. If because of riots, wars, strikes, civil disturbances, national emergencies, health emergencies and the dictates of law enforcement or other acts beyond the control of management it is impossible to open or to complete the show, no refund will be made.  
\* ALL TROPHIES MUST BE CLAIMED DAY OF SHOW. NONE WILL BE MAILED  
\* THE OWNER OR HANDLER of each dog assume full responsibility for said dog  
\* THE SHOW-GIVING CLUB, Show Secretary, their Agents, employees, etc., assume no responsibility for any loss, damage, or injury sustained by the exhibitors, handlers, or any of their dogs or property.
